AUGUST 23, 2020- KINGSTON, MA ó The Silver Lake Shootout attracted six pilots for a day of Formula GX action. The weather was sunny and hot. The breeze was quite light and not a factor.

Round one action saw Cody Bishop get off to the best start posting a 620 point win. Chris Sarnowski and Neil Simpson were in close pursuit as they flew each other to a one cut apiece draw in their first round match. In round two Neil got past Cody with a two cut win. Meanwhile Joe Fustolo and Chris were flying each other to a one cut apiece round two draw. In round three Cody got an airtime win over Chris. Neil and Brian Stas also posted airtime wins in round three. In the final round Chris got a one cut win over Bill Bishop to propel himself into second place when, in the next match, Cody took an airtime loss to Joe. In the final Neil matched up with Brian. Lots of twisting and turning early with Neil getting a cut somewhere around the halfway point and then after a little more good action a mid-air occurred. In the end Neil still had enough points for the contest win followed by Chris and Cody.



### Rumors, Facts Etc.

NEMESIS ONLY CONTEST: Two guys have airplanes built and three more guys have airplanes under construction. Looks like it will happen at one of the October contests.

SHOOTOUT RULES: The "Shootout Rules" that will be used for the "Nemesis Only" contest(s) can be found on page six. Flown, at least initially, in a single or double elimination format at the end of a GX contest(s). This will make it practical to compete with just one airplane. Speed Limit will be 75mph.

WILL ROGERS: This month we auctioned off additional airplanes, engines and equipment from the Will Roger's estate for an additional \$220 to the contest fund.

### **Shootout Rules-Kill Version**

These rules, minus a few tweaks, were conceived by Gene Pape. Gene may or may not approve of the tweaks, however, in the interest of giving credit, where credit is due, Gene is the gentleman who is the inspiration behind this concept.

Each match will have a 1 minute staring period where the pilot will start his own engine, get to the pilots circle, and be ready for his plane to be launched. At the end of that one minute period, pilots not ready to launch will forfeit the round. If both pilots are ready to launch, the signal to start will be given. Both planes will be launched from 180 degrees apart, and combat will begin immediately for a 3 minute match period. The match will be scored with 1 point for the first cut, 2 points for the second cut and 3 points for each additional cut. A kill wins the match if the pilot executing the kill completes the three minute match period. In the event 1 airplane crashes, or lands for any other reason before the end of the 3 minute period, the other will win the match. If both pilots land before the end of the 3 minute period both forfeit the round. Ties will be re-flown. Can be flown single, double or triple elimination
